



# **LIFETOOLS FOR TEENS**

## **Participant's Informed Consent**

**Crossings Community Church's *LifeTools for Teens*** is a psycho-educational group using a biblically-based curriculum that helps your teen better understand and respond to family life stressors. ***Please be advised that CCC LifeTools for Teens is not therapy, nor is it in any way intended to provide substitute for therapy.*** Our facilitators are volunteers, not professional counselors. If at any time you feel your teen is in need of professional counseling services, one of the **CCC LifeCare** Counselors will be happy to talk with you about referral to an appropriate community resource.

Each teen must have at least one parent enrolled and participating, either in the ***LifeTools for Teens Parent Group*** or in a ***CareSeries*** support group, to be eligible, week-to-week, for class attendance. **With no exception, each teen must have a parent, or, a pre-approved "parent designated care-giver", on-site the entire time.**

Any and all information offered by either parent or teen will be treated with respect and sensitivity. Such information is typically retained within the leadership of the **CCC LifeTools for Teens** program but with some ethical and legally mandated exceptions.

Please be informed that to ensure the health and safety of every teen, Oklahoma law stipulates a "Duty to Report" and/or a "Duty to Protect." This requires any and all adults to report suspected or confirmed reports of any abuse or neglect to *Child Protective Services*. It is the Church policy that all adult leadership of **CCC LifeTools Teens** will comply fully with these statutes. **Please Initial \_\_\_\_\_.**

Both Parents are expected to communicate directly with one another regarding their teen's involvement in **CCC LifeTools for Teens**. Group facilitators are not available as mediators between estranged parents or family members. **Please Initial \_\_\_\_\_.**

Please be informed that **CCC LifeTools for Teens** does not intend to meet criteria for any court-ordered requirement or certification. Because of this expressed policy, **Crossings Community Church** will not provide verification of enrollment, documentation of participation, nor interrogatives regarding a teen's or parent's participation in the program.

I expressly release and hold harmless **Crossings Community Church**, it's employees, and all other persons working with the church on its behalf from all liability, loss, damage, claims or actions for injuries, damages or judgments of any kind which may arise in connection with the **CCC LifeTools for Teens** program.
